The Immigration and Deportation Act, 2010

(Act No. 18 of 2010)

The Immigration and Deportation (General)(Amendment) Regulations, 2024

IN EXERCISE of the powers contained in section 59 of the Immigration and Deportation Act, 2010, the following Regulations are made:

1. These Regulations may be cited as the Immigration and Deportation (General) (Amendment) Regulations, 2024, and shall be read as one with the Immigration and Deportation (General) Regulations, 2011, in these Regulations referred to as the principal Regulations.

2. Regulation 52(2) of the principal Regulations is amended by the deletion of the words "item C of the Fifth Schedule" and the substitution therefor of the words "Part C of the Fourth Schedule".
