**The Investment, Trade and Business Development
(Fintech City Multi-Facility Economic Zone) (Declaration)
Order, 2025**

IN EXERCISE of the powers contained in section 7 of the Investment, Trade and Business Development Act, 2022, the following Order is made:

1. This Order may be cited as the Investment, Trade and Business Development (Fintech City Multi-Facility Economic Zone) (Declaration) Order, 2025. Title
2. In this Order, unless the context otherwise requires— Interpretation
 - “licence holder” means the licence holder specified in the Second Schedule to this order; and
 - “special economic zone” has the meaning assigned to the words in the Act.
3. The area comprising the piece of land described in the First Schedule is declared as a special economic zone. Declaration of Fintech City Multi-Facility Economic Zone as special economic zone

Facilities to be provided by licence holder in special economic zone

4. (1) The licence holder shall provide, within the special economic zone, referred to under Paragraph 3, infrastructure and facilities which are suitable for the operation of the industries specified in subparagraph (2) and which shall include—

- (a) buildings;
- (b) power supply facilities;
- (c) water and waste disposal facilities;
- (d) public transport facilities; and
- (e) road network.

(2) The infrastructure and facilities referred to in subparagraph (1) shall be suitable for the operation of—

- (a) retail space;
- (b) office park;
- (c) entertainment, dining and sports facilities;
- (d) conference centres;
- (e) hotel resorts, spa and villas;
- (f) state-of-the-art golf course;
- (g) primary and secondary schools;
- (h) university;
- (i) research facilities;
- (j) light industries;

Sale, export and disposal of goods produced in special economic zone

5. The goods produced or services provided in the special economic zone referred to under paragraph 3 may be sold, exported or otherwise disposed of in the ordinary course of business.

Activities prohibited within special economic zone

6. The licence holder shall not carry out any activity within the special economic zone referred to under paragraph 3 that is not authorised by a licence or permit granted for purposes of operations under paragraph 4(2).

Removal of goods from the special economic zone

7. Goods produced or services provided in the special economic zone referred to under paragraph 3 may be removed in the ordinary course of business.
